Dear Members

As we reflect on the opportunities and successes of 2023, let me start by thanking our members, employees and credit union volunteers for their exceptional support during our 75th year of service.

Our credit union remained strong in the face of challenging economic forces, thanks to the leadership of our experienced executive team and our dedicated Board of Directors. We relied on these leaders to scan the financial horizon, identify economic challenges and opportunities, and create the best path forward for our members.

During the year, we focused on listening to our valued members and took action to support them:

- · Offered a utility relief grant and loan for overseas military service members. Our team created a program to support military service members facing high utility costs due to the conflict in Ukraine. Our overseas garrison leadership reached out to us and trusted us to provide a solution for members during a difficult time totaling more than \$41,000 in grant relief.
- · Fortified our connections with our military communities. We were honored to serve as the premier sponsor for the Joint Base McGuire-Dix-Lakehurst Power in the Pines Air and Space Open House in New Jersey and the Freedom Run in Wiesbaden, Germany.
- · Created a member service culture that ensured our staff sought the best solution to meet each member's individual needs. Our Member Satisfaction Scores (NPS) reached Best in Class levels during 2023, which set us apart in the financial services industry.

These initiatives showed our credit union's commitment to providing strong financial guidance and investing in the resources that touch the heart of our communities. The combination of these efforts makes Andrews Federal a truly special place, as evidenced by the national and international awards we received last year:

- Andrews Federal received the Distinguished Credit Union of the Year recognition from the U.S. Department of the Army. The honor specifically referenced our work at USAG Benelux, which serves military members in Belgium, The Netherlands, and Luxembourg.
- · Andrews Federal was also recognized as a Great Place to Work for the 4th consecutive time. This award shows our commitment to an exceptional corporate culture. This culture translates into the delivery of a better member experience throughout the organization.
- · Andrews Federal Board Member Emeritus Roger Scearce was inducted into the Defense Credit Union Council Hall of Honor. Brigadier General Scearce has served the credit union since 1996 in roles ranging from Supervisory Committee Member to Treasurer to Board Chair. General Scearce is a tireless advocate for credit unions and military service members and we are grateful for his loyal service.

We are proud of all we accomplished in 2023, and we could not have achieved these successes without your support. Your membership and loyalty have kept Andrews Federal strong for 75 years and counting, and we look forward to continuing our service to you in 2024 and beyond.

A MESSAGE FROM **OUR PRESIDENT & CEO**

Dear Members

Our 75th anniversary marked a special milestone for our credit union. We appreciate your past loyalty and are committed to continuing to provide innovative products and services in the future.

In 2023, Andrews Federal earned a Certificate of Excellence from America's Credit Unions, a credit union industry research group, for providing our members with \$17 million in additional direct financial benefits, which translates to \$270 more to each member household. Members with multiple products earned \$1,372 in additional direct financial benefits per household by embracing more of our products and services:

- Receive checking rewards. Whether earning 3% cash back on debit card purchases, or utilizing a checking account that offers an outstanding 6.00% APY, Andrews Federal focused on providing members with greater rewards when using their checking account for everyday transactions.
- Buy a home. Andrews Federal offered some of the lowest mortgage rates in the nation, giving members access to the funding needed to establish their families or move into their dream homes. The credit union also provided financial education resources to assist members throughout the homebuying process.
- Purchase a vehicle. Acquiring a vehicle became easier for members as a result of Andrews Federal offering deferred first payments, giving members 90 days to start driving and enjoy their vehicles before making loan payments.
- Manage finances. Enhanced Digital Banking capabilities continued to be a priority for Andrews Federal members. During this past year, we launched new services, ClickSwitch and CardSwap, both of which made it easier for members to make payments, manage subscriptions and use Andrews Federal as their primary financial institution.
- Save for goals and dreams. The credit union offered resources that were nationally recognized, including market-leading share dividend rates. Our members earned more than \$32 million in dividends on their deposits in 2023 by choosing Andrews Federal.
- Plan for the future. Andrews Federal members also had access to financial and investment professionals such as GreenPath Financial Resources and LPL Financial to help plan for a successful future.

Andrews Federal continued to demonstrate strong financial performance. Our credit union is well capitalized with a net worth ratio of 11.00%. Our efficiency ratio of 51.95% indicates that we are safeguarding members' finances as we make decisions about new products, services and opportunities.

Financial services have changed over the years and new technologies have proliferated in the credit union sector. Our commitment to providing outstanding service to our members has remained our primary focus. As your credit union leadership team, we are proud to serve and support you, to provide resources for your financial needs, and to ensure your financial institution remains strong and stable for years to come.

ANDREWS FEDERAL IS **COMMITTED TO EDUCATIONAL EXCELLENCE**

Supporting the educational goals of our youth is a cornerstone priority for Andrews Federal.

In 2023, Andrews Federal awarded ten \$2,000 scholarships and two \$7,500 scholarships to graduating high school seniors. The credit union also provided educational summer camp experiences to 11 students for a total of \$40,750 in scholarship funds committed to advancing these students' educations.

Credit union leaders also committed resources to improving educational experiences throughout our communities by adopting classrooms and funding school projects, sponsoring book drives at local branches, supporting Scout troops, and building an accessible sidewalk library for a local military charter school.

We take pride in providing resources that enhance students' educational journeys and continuing to build stronger, more successful communities.

I am pleased to report that Andrews Federal performed exceedingly well in 2023 ending the year with total assets of \$2.31 billion and net income of \$18.4 million. We also maintained a very strong liquidity ratio of 58.63%.

Per the Federal Credit Union Act, the Supervisory Committee is responsible for ensuring that the Board of Directors and management of the credit union meet required financial reporting objectives and establish practices and procedures sufficient to safeguard members' assets. The Supervisory Committee assists with oversight responsibilities including internal controls, audit processes and monitoring compliance with laws and regulations. The committee oversees and reviews audits to determine if management procedures meet required standards.

The Supervisory Committee selected the Certified Public Accounting firm of Doeren Mayhew, CPAs and Advisors, to audit the consolidated financial statements of Andrews Federal Credit Union. The firm performed the annual financial statement audit for 2023. Copies of the examination are available upon request. It is the opinion of the Supervisory Committee that Andrews Federal Credit Union remains strong and well-positioned for future growth.
